The above numbered exchange agreement is modified as follows:

The return period of the exchange agreement is changed to read: "Contractor shall return all exchange oil plus premium barrels to Bryan Mound SPR site during the months of June 2024 through September 2024." Payment and Performance Guarantee, Paragraph 4 of the agreement, is modified to reflect an expiration date of November 30, 2024. The payment term of the agreement is changed to 8.6% of actual crude oil received from the SPR with a minimum premium amount of 30,960 barrels.

All other provisions remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
