

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The return period of exchange agreement 22PO0006 is amended as follows: Contractor shall return 2,430,000 exchange oil plus premium barrels to the Big Hill SPR site from July 15, 2025 through August 31, 2025. Contractor's oil return schedules must be approved by the Government prior to delivery. There is no adjustment to the premium as a result of this extension. However, the Irrevocable Standby Letter of Credit must remain in effect through October 31, 2025.

All other provisions of the agreement remain the same.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
