3. TERM - 1,500,000 barrels of exchange crude oil plus applicable premium barrels will be returned to West Hackberry during the months of July 1, 2022 through August 31, 2022 in lieu of the original delivery return month of January 2022. Contractor's oil return schedules must be approved by the Government prior to delivery. Also, see Provision 18 for additional scheduling requirements.

4. PAYMENT AND PERFORMANCE GUARANTEE – The Irrevocable Standby Letter of Credit shall expire on September 30, 2022.

All other provisions of the agreement remain the same.
