3. **TERM** – The Government will commence delivery as soon as possible with an objective to be completed by September 30, 2021. Contractor shall return all exchange oil plus premium barrels to the West Hackberry SPR site during the month(s) of **June 1, 2023 through August 31, 2023**. Contractor's oil return schedules must be approved by the Government prior to delivery. Also, see Provision 18 for additional scheduling requirements.

4. **PAYMENT AND PERFORMANCE GUARATEE** – The Irrevocable Standby Letter of Credit shall expire on **September 30, 2023**.

All other provisions of the agreement remain the same.
