3. TERM – The Government will commence delivery as soon as possible with an objective to be completed by September 30, 2021. Contractor shall return all exchange oil plus premium barrels to the Bayou Choctaw SPR site during the month of **October 2024**. Contractor's oil return schedules must be approved by the Government prior to delivery. Also, see Provision 18 for additional scheduling requirements.

There is no adjustment to the premium due as a result of this extension.

4. PAYMENT AND PERFORMANCE GUARANTEE – The Irrevocable Standby Letter of Credit or Surety Bond must remain in effect through **November 30, 2024**.

All other provisions of the agreement remain the same.
