This provides funding of \$9,434,159.15 for Facilities (00400) funds for estimated Hurricane Repairs, (2) \$3,889,995.27 of Petroleum Account (00700) funds to cover future Sale, Fill, and Exchange requirements, and (3) \$3,000.00 of Composite Adversary Team (CAT) funding (01164).
